#### **6. ACCIDENTAL RELEASE MEASURES**

#### 6.1 Personal precautions, protective equipment and emergency procedures

# 7. HANDLING AND STORAGE

#### 7.1 Handling

#### 8.2 Personal protective equipment

Respiratory protection:

Use local exhaust ventilation around open tanks and other open sources of potential exposures in order to avoid excessive inhalation including places where this material is openly weighed or measured.
